

COUNTY RESPONSIBLE FOR BIGGEST SHARE OF PROPERTY TAX INCREASE Over 40% over the past four years.

Most people don't know what county government does. They don't even know that the county is funded by their property tax. Property taxes go to fund three government agencies, the local school system, the municipality and the county.

Roughly 50% of the property tax goes to the school system, about 25% goes to the municipality and about 25% goes to the county. Taxpayers keep tabs on their school board, mayors and councils but no one knows what the freeholders do with our money. Most people don't even know what a freeholder is.

The Freeholders run the county government, also known as the "invisible" layer of government. The Freeholders are able to do anything they want without any consequence. They have used the luxury of their actions going ignored and undetected to increase their portion of the property tax over 40% over the past four years. Since the Freeholder Board is made up entirely of Democrats, there is no one in the position to challenge what is happening.

If the local school board, mayor or council ever raised their portion of the tax at the rate the county has the officials would be voted out the following year. Freeholders are immune to that threat because they are not connected to the rise in taxes.

Most people don't look at their tax bill. The tax is usually paid along with their mortgage or is figured as part of their rent. If they did look they would see the school system, municipal and county portions separated. They would also see a fourth line on the bill, the open space trust fund, another county tax. The freeholders crafted this tax as its own line item, but make no mistake it is a county tax and a hefty one.

Unless there is a change on the freeholder board, taxpayers can expect the same increase next year. It is costly for everyone, Democrat, Republican and Independent alike. It is for the benefit of everyone in the county that Republicans are voted in this election to balance the one party rule and stop another year of oversized tax hikes.

Every dollar that the county takes from the pool of property taxes is less that can go to local school systems and municipalities.

COUNTY WORK FORCE MORE TOP-HEAVY New administrators account for \$20 million in payroll increase.

The payroll for the County of Union has increased from \$123.2 million to \$144.9 million over the past three years. If the \$20 million jump in payroll was spread over the 2,840 employees the county had in 2000 it would mean every employee received a 6% raise per year for three years. This did not happen. In reality, 8% of the employees accounted for the \$20 million increase.

The county keeps the total number of employees about even, 2,840 in 2000 and 2,860 in 2004. This does not include about 300 seasonal employees. What the employee list does reveal is that as rank and file workers leave, the county manager creates a new administrative position. What has happened is that the county is top heavy with administrators with a shortage of service providers.

The fancy word for creating new administrative positions is called "reorganization". Each year the county does a shuffling of departments and divisions. With each shuffle a new

layer of administration appears. Titles appear that never existed, with salaries of \$80,000 and up.

There are many problems that come along with this overgrowth of administrators. One, the positions are filled with patronage being appointments, many unqualified and incompetent. Two, the salaries are draining the county coffers. There are less employees at the working levels and so services are being cut back. The lack of proper supervision and direction is making even the most capable employee less productive.

Moral among the county work force is at an all time low. The environment of political favoritism has corrupted the merit system. Worthy employees are being passed over and dedicated workers are not being rewarded. A reversal of this top heavy structure of government must be implemented. Pressure must be put on the freeholder board to stop using the county's payroll as a political slush fund.

The claim that the increase in property taxes is beyond their control is an outrageous lie. They have raised their portion of the property tax over 40% over the last four years. Public records show that kickbacks in the

form of no bid contracts and patronage jobs going to campaign contributors and political operatives have accounted for the increases. We need to restore open and honest government with accountability.

CRISIS BROUGHT ON BY INCOMPETENCE AND CORRUPTION

Most voters don't know what effect county government has on their property tax. They relate property tax to either their school system or their municipality. What they don't realize is that the county government is responsible for the bulk of their property tax increase.

Our property tax situation has been categorized as being in a crisis. So much so that there has been a call for a constitutional convention in order to address the issue. The belief is that the crisis has occurred because of increases that are beyond the control of our elected officials. This opinion is not only absurd but gives

the elected officials a free pass on accountability. It is the charge of the elected officials to operate an efficient and effective government. The crisis occurred when our leadership shirked their responsibility and put self serving political aspirations before the public's wellbeing. There is no better example of this than the County of Union.

In his own words, last year, the county manager, George Devanney said the county was in a budget crisis. What he failed to explain is that he was responsible for it happening.

Devanney was appointed county manager in 2000. His strongest

LOWER LEVEL STAFFERS ASKED TO SUPPORT TOP MANAGEMENT GROWTH

Here are some samples of how the incompetence of the county manger manifests itself in a ballooning payroll that accounts for one third of the entire county budget.

The county laid off 96 corrections officers in 2001 when they closed the old jail in order to save money. But instead of lowering the payroll, the county created new administrative positions in other departments. Now the county has a shortage of cor-

boosted to \$90,000.

The employee union representative, Joan Tapia, said that asking the lower staff to give up paid work days to help the county close a \$27.5 million deficit was kind of silly.

Another program to cut salaries of the lower staff was a voluntary leave program where the manager is asking non-essential employees to take up to three weeks off without pay.

credential is being the nephew of State Senator Ray Lesniak. It was under the influence of their party boss that the Freeholder Board, made up entirely of Democrats, appointed the nephew, even though he had no prior management experience. He was put in charge of a \$300 million budget and 3000 employees. This was the start of the crisis.

The county became the well from which the Union County Democratic Committee siphoned millions of tax dollars and funnelled them to campaign contributors and political operatives in the form of no bid contracts and patronage jobs. The well was replenished each year with increases in the county portion of the property tax and increases in service and licensing fees.

Since 2000 the county budget has swelled to over \$366 million. That's a million dollars a day! The county debt has surpassed the \$300 million mark. In the last three years alone the county spent over one billion dollars. Voters are looking for accountability but are not finding it.

The county is an invisible layer of government. The abuse of the system is out of range of the voter's radar. This is not by chance but by design. Public participation is not only discouraged but is rejected. Access to public records is either denied or delayed and responses are not always truthful.

officials pointed to when explaining the increase in spending are the rise in insurance costs and public safety. Using public safety is a sentimental diversion from the real causes. For instance, in 2003 the increase in taxes attributed to public safety was just \$1.4 million. Where as the county debt service has bounded over \$11 million since 2002 and is now \$33.3 million.

The cause for the county's debt is not, as claimed, "beyond our control". Indeed, the county debt is precisely the thing that the elected officials and county manager are supposed to control.

All agree that the property tax situation in Union County is in a crisis. But we don't need a constitutional convention to fix it. The voters need to elect new Freeholders who have the integrity to do the will of the people and not their party. The all Democrat Freeholder Board has been in power for ten years. They are not about to cut the flow of funds into their party's coffers.

They will continue to do the bidding of the senator and his nephew, who will be long gone when it will be time to pay the tab. Of course the taxpayer will be there to pick up the bill. Taxpayers can look forward to more of the same treatment next year unless voters make a change in November and vote Republican.

rections officers and a higher payroll.

The county offered a generous retirement program to entice employees to leave. 142 workers took early retirement but 116 positions were replaced, starting at or above the rate of the person who retired. A number of top administrators earning \$80,000 and up were hired back as consultants for the same rate, collecting both their retirement and salary. The county hoped to save \$1 million per year for the next ten years with their plan but it has been more costly.

Devanney's budget projected that the county would save \$500,000 in a furlough program in which he asked employees to voluntarily take two two days off without pay. The county only realized \$200,000 in savings. They then rewarded those who took the days off raises. The average wage of those who participated was

An additional scheme to entice low level employees to take off was the Vacation Purchase Program in which the county wants employees to purchase vacation days. They would get 5 days off if they give back three days pay. The county manager says he can raise as much as \$100,000 from the sale.

During this time the manager gave every employee four free hours to go for medical and cancer testing at a cost of \$250,000.

The county doesn't mention who would be doing the work of these employees while they take the time off, or how the projected savings for these programs are used to balance the budget yet none come close to realization. Every year the county must find ways to close the ever widening gap between spending and revenue. The only solution is to raise our taxes. 🐲

OPEN & HONEST GOVERNMENT

PROBLEM:

• Few people know what the county does until after the fact. The county either denies or delays access to public records and has been proven to misrepresented the truth on many occasions.

SOLUTIONS:

MAKE PUBLIC RECORDS AVAILABLE ON THE INTERNET

(The county has already spent millions on technology that is not being used)

The method the county uses for archiving and retrieving public records is costly and time consuming. They keep this method to retain control of the information which enables the Freeholders to stall the public long enough to get a resolution passed. The county refuses to fax documents and denies the digital existence of them. This is absurd. Public records should be available on-line.

ENCOURAGE PUBLIC PARTICIPATION

(The county has a policy of not answering questions at public meetings)

Strange but true. The Freeholders contend they do not have to answer questions from the public at the public comment portion of a meeting. We also think that the meetings could be held in the community that is effected by a big program.

NEGLECTING ESSENTIAL SERVICES

When money is misspent it is taken away from the service for which it was intended

Many of the services and products that the county purchases can be provided by county businesses. We believe that every business in Union County should have the opportunity to bid on the contracts that the county gives out.

The county bypasses its own procurement process to award no bid contracts to campaign contributors. We think that this form of kick backs is unethical and adds to the cost of government and leads to higher taxes. This is possible because all 9 elected Freeholders who run the county are one party, Democrat. It has been this way going on ten years. There is no opposition to their decisions and the public isn't aware of how their county tax dollars are being spent. There needs to be a balance on the Freeholder Board so that the back room wheeling and dealing can be stopped.

For example, the county uses Royal Printing in Jersey City for many of its print jobs. There are 100 printers in Union County that are capable of doing the work yet they don't even have the opportunity to bid on the job. It just so happens that Royal Printing is a big Democratic campaign contributor.

One print job went to SVO Printing, a printing broker located in Rockaway, NJ. He did a print job for the county and charged \$40,000 more than a competing quote from a county printer. The broker happened to be Richard Stender, the husband of Freeholder Linda Stender who is now an Assembly Woman.

This practice is extended to every aspect of purchasing from catering to flowers. There is hundreds of thousands of dollars spent on flowers. It just so happens that the floral shop the county uses is owned by the wife of Democratic Mayor of Linden, John Gregorio. This is outrageous.

Another contributor that has a county contract is MediaSquared, Inc., located in New Brunswick. The company produces artwork, printing and other advertising services for the county. They also produce the artwork for the Union County Democrat Committee, sometimes using the design and artwork paid for by the county taxpayers.

MediaSquared does hundreds of thousands of dollars of work for the county, besides the \$6,000 a month retainer for consulting. According to the resolution, the county justifies giving the no-bid contract to MediaSquared based on their "extensive involvement with the County of Union in planning and development of a marketing plan for the county." A request through the Open Public Records Act found no such marketing plan.

The practice of no-bid contracts and jobs going to campaign contributors and political operatives must stop. The only way this can be achieved is by electing Republicans to sit on the Freeholder Board. There needs to be a balance. The taxpayers need a watchdog.

If elected, the Republicans can challenge the Democrats on this corrupt practice. They could push to implement a system that gives the opportunity of bidding on county contracts to every Union County business for a fair price to the taxpayer.

Right now there is no accountability in county government and the all Democratic board is taking full advantage of that.

RUNNELLS BUDGET BEING SACKED

When MediaSquared produced the Freeholder campaign commercial featuring Runnells Hospital it sapped the budget of the Hospital of \$240,000. This is money that could have been used to care for the patients and residences of the hospital.

When patronage jobs at the hospital are doled out to Democrat operatives and elected officials like Assembly Woman Linda Stender, \$60,000; and Rahway Councilman Bob Rachlin, \$44,500; and Fanwood Council candidate Barbara Baldasarre, \$95,500; it hurts the hospitals budget. There are a slew of volunteers who struggle to provide patients and residences with services. They try to raise money from people and organizations, and by selling snacks and gifts.

Runnells is an essential service that the county delivers but it has struggled through the years because of funds being pillaged.

This misdirection of funds is perpetrated on the budgets of every department and program. It becomes critical when the service that suffers is one of health or safety.

SAFETY SHOULD BE FIRST - IT'S NOT

The Union County Freeholder Board shamelessly used the events of 9/11 to boost their budget and increase property taxes, as if it would be "unpatriotic" to challenge their decision.

Taxpayers would tolerate an increase in taxes if it was going toward services that were returned to them, such as safety and security and health and welfare. The outrage from the taxpayers stems from the freeholders using taxes for nonessential self-serving projects.

The budget of the County Manager's Department increased 180% where the budget for Safety and Security went up only 110%. The percentage of the budget that is appropriated for Health and Welfare actually went down!

The freeholders explained that the increase in the budget and taxes were do to "extraordinarily difficult times." If this is true why pay \$1.8 million to put an atrium on the administration building? Couldn't the

atrium wait for when the times were just ordinary.

Freeholder Daniel Sullivan crowed about a \$2 million dollar grant that the county received from the federal government. This is the big item they are campaigning on. The claim to this accomplishment came after Sullivan blamed President Bush for the county not receiving their fair share of federal money.

Security must be a priority in these trying times. Yet, while the need for anti-terror equipment should be our main concern, the freeholders spent almost as much on their atrium as the money they received from the federal grant. They have also started to spend \$6 million of the \$20 million earmarked for renovations on the Union County Arts Center.

Security does come down to money and according to the budget figures Security Health and Safety is not high on the all Democrat board's priority list no matter what they say. Numbers don't lie.

FREEHOLDERS ARE LAX IN EFFORT TO COMBAT DOMESTIC VIOLENCE

October is Domestic Violence Awareness Month and with domestic violence being the 2nd most reported crime in Union County it seemed appropriate to get some information out there regarding this issue.

The NJ Domestic Violence Fatality Review Board was established by executive order in March of 2000, its purpose was to study fatalities in NJ that were a direct result of domestic violence (DV) in order to identify strategies for improving our state's response to this problem. What made the study interesting was that the research team studied 67 cases of murder-suicide and determined that these 67 cases actually produced 145 fatalities over a 5-year period from '94 thru '99. Besides the 67 homicides and 67 suicides there were also 11 other fatalities associated with these cases including a responding police officer, 7 other friends and family members, 2 children of victims and a caregiver. Currently 15% of homicides in NJ are DV related. These are sobering facts coupled with the statistic that one in five women will experience a domestic violence incident in their lifetime and that recently there have been several high profile cases in Union County, it appears that DV has the capability of touching every resident's life in someway.

We may be the abused, we may have a victim in our family such as a sister or daughter, it may be a neighbor, perhaps our child's teacher or scout leader and unless someone tells vou their story or hints in conversation of their plight you probably wouldn't allow the possibility to cross your mind. DV has been the nasty hidden secret of our society that "good people" don't acknowledge and many victims still deny. Several laws have been passed in NJ since 1982 some intended to protect victims such as the stalking laws and others which deal with the gathering of data from Police Departments and Prosecutors so we can learn how to combat these crimes. And just two weeks ago the NJ Department of Consumer Affairs announced that over \$1 million was being distributed to battered women's shelters as well as transitional housing programs, evidence that some of our tax dollars are being well spent.

Union County, sad to say, is lagging behind. For starters you will be hard pressed to locate a Freeholder resolution declaring October. Domestic Violence Awareness Month. Second, financial support to the Battered Women's Shelter and their other related programs has continued to be sparse, less than \$10,000 per year in the past few years and only about \$400 this year. What a worthy cause to support, a program that helps people empower themselves to take control of their lives while developing "safety plans" to keep themselves and their children alive and well. As illustrated, surviving domestic violence can be a life or death matter. Why has so little money been appropriated for DV, a very real "quality of life" issue, while so much is spent for non-essentials? Somehow our county government has lost its way and forgotten that its purpose is to ensure the health and safety of the citizens. When the freeholder board gets it's priorities back to where they should be and finally supports worthy programs, which actually help people, than they will truly be "Connected to you".

CLEAN PARKS

The county has a vast system of parks that have been neglected and overrun with geese waste. It has become impossible to play in the fields or lay a picnic blanket down. For the past three seasons the freeholders have been gassing the geese in an expensive, unsuccessful effort to try to control the population which grows by 15% a year.

The freeholders stated that they have exhausted all alternatives to deal with the problem. A request for a record of any geese management program from the last 8 years showed that statement to be a lie. The freeholders have never implemented a comprehensive program to manage the problem. Though they are quick to tout how dedicated they are to open space. There are solutions to controlling the geese population. They are even used successfully by private golf courses and corporate campuses located in Union County. One thing that is for certain is the problem will continue to multiply. The present freeholder board has refused to address the issue and the county manager has been inept at implementing a strategy. Without a plan, the 5,574 acres of county parkland will remain an uninviting mess overrun by geese instead of people.

PAY TO PLAY/NO-BID CONTRACTS/KUSHNER *The practice of kickbacks to campaign contributors*

Union County Democrat Freeholders should follow the Governors lead NOW and change their system of awarding professional contracts.

"Now is the time for the all-Democrat Union County Freeholder Board to take a look at to whom they are awarding millions of dollars in professional contracts." stated Republican freeholder candidate Patricia Quattrocchi. "A simple comparison of campaign contribution records and freeholder resolutions since 2000 is a real eye-opener and shows that "Pay-to-Play" is rampant in Union County government," Quattrocchi said.

Quattrocchi and running mates Joe Renna, Frank Arena and Bruce Paterson are urging the all-Democrat freeholder Board to do the right thing by immediately putting into place financial restrictions to regulate the awarding of contracts to developers, contractors and professional service firms such as lawyers, architects and engineers.

"It doesn't take a rocket scientist to see what is going on here," says Republican freeholder candidate Bruce Paterson. "The trail of paper speaks for itself, evidenced by the recent awarding of several contracts relating to the purchase and renovations to the Union County Arts Center. The contractor is a big contributor having given in the neighborhood of \$70,000 to the Union County Democratic Committee alone since 2000," Paterson added.

The practice adds to the cost of services which is passed along to the

taxpayers," Joe Renna explained.

"Our freeholders often award these contracts to companies that are not even located in Union County, thus rewarding them for their contributions." said GOP freeholder candidate Frank Arena. "Recently they ignored the fact that the principals of JCA, a Monmouth County-based engineering firm, had pleaded guilty to violating the law and rewarded them with another sixfigure contract - this is unacceptable. The Democrats have ignored our demands to return nearly \$200,000 in campaign contributions from two heavy contributors to their machine, Charles Kushner, Ronald Manzo and their companies. It's time that they realize that they work for the people of this County and not the Democrat party," Arena said.



When he ran in 2001 Sullivan blamed the county problems on Governor Whitman, who like Bush, is a Republican. Renters hit just as hard by property taxes

There is a perception among the general public that renters don't pay their fair share of housing expenses and thus are not entitled to the same rights and privileges as homeowners. Information gathered from the last US Census regarding housing in Union County in the year 2000 contradicts that notion. The census showed that there were 192,945 housing units in Union County with a little under half being renteroccupied units and the rest owner occupied units. 29.1% of households who rented expended 35 percent or more of the household income for housing, while 28% of owners spent less that 15 percent. Rental units in county increased the by approximately 4,000 over the 10-year period from 1989 to 1999. The increase in the number of private single-family units was not available.

It is apparent that renters contribute substantially to the economy of Union County since landlords traditionally base rental charges on the costs incurred to operate the rental property, cover mortgage payments, local and county property taxes, maintenance costs and generally build in a small profit. Some municipalities have rent control ordinances to protect tenants from unscrupulous landlords who raise rents unreasonably to realize substantial profits while neglecting to properly maintain the property. In New Jersey any rent increase over 4is considered to be 5% unconscionable and tenets, even those without leases in non-rent controlled buildings, have recourse in the Landlord Tenant Relations Courts to settle the matter of an excessive rent increase, however property taxes can be considered a viable cause to increase a tenant's rent.

Landlords generally pass along property tax increases to their tenants and in Union County these increases have averaged approximately 40% over the past 4 years. In the case of a 3 or more unit building this can translate into a substantial monthly rent increase. By electing to office those candidates who are sensitive to their needs, renters can be assured that they will be able to continue to afford to stay in their "homes." By voting they can be assured that they have a voice in government, which is by and for all the people.

"As a renter I personally understand the plight of tenants and landlords first hand, this has been my family's home for over 23 years." said Freeholder candidate Patricia Quattrocchi. "I prefer not to have to move and will work hard for no tax increase budgets so that my landlord will not be forced to raise my rent to cover his property taxes."

The team of Joe Renna, Patricia Quattrocchi, Frank Arena and Bruce Paterson believe that renters have the ability to stop the county and municipal tax increases which are passed along to them by their landlords by voting for the team which proposes to reverse the current trend.

Democrat Freeholder Candidate Resigns But Refuses to Withdraw From Election

In the wake a recent arrest Freeholder John Wohlrab, the Union County Democrats announced that Wohlrab was resigning from the Board Freeholder effective immediately. Wohlrab was arrested by the Linden Police Department on charges stemming from alleged domestic abuse. Wohlrab, a governmental affairs employee of Waste Management, Inc., was appointed last year to fill the unexpired freeholder term of Senator Nick Scutari. "The Union County Democrats have sunk to a new low in using the legal system to manipulate the electoral process and disenfranchise the voters of Union County," said Phil Morin, Union County Republican Chairman. The Union County Democrat Committee will appoint а replacement for his vacant freeholder seat. Wohlrab, a candidate for this seat in the November election, has refused to withdraw his name from the ballot but has indicated, if elected, he will not serve. "First Torricelli, then Suliga and now Wohlrab, said Morin. Through this latest ballot sleight-of-hand, voters from Elizabeth to Springfield to Plainfield are being disenfranchised by the Union County Democrat machine's manipulation of this freeholder seat. Wohlarb's seat was originally vacated when thenfreeholder Nick Scutari filled the Senate seat of Joe Suliga following an arrest for alleged public intoxication and harassment of a female casino patron.

The local chairmen do get first consideration. The following are the chairs of the local Democrat committees and the patronage position they have with the county.

Other chair persons secure employment in other government agencies like Doug LaPlaca of Roselle Park who gets a paycheck from the Department of Labor. Chairman Bill Malone of Rahway gets a good share of no-bid professional contracts for his insurance company that the Freeholders dish out.




