OFFICER HEARNS ASSISTS WITH SPECIAL DELIVERY

On Sunday, March 30, 2014 at approximately 8:59am, Cranford Police officers were called to 85 James Avenue on a reported pregnant woman who had passed out. First to arrive on scene was Officer Nelson Hearns, a veteran officer with over 11 years of patrol experience. Once at the residence, he found Jody Copier, age 31, who was awake and in labor. Copier's husband Scott Kraft was also present at the scene.

Hearns immediately moved to assist and saw that the baby's feet were presenting first in an imminent breech birth, a rare and potentially life threatening delivery presentation. Hearns drew on his years of experience to reassure and position Jody while using a towel and supporting the baby during the delivery. Kace Kraft was born at 9:11am, weighing in at 4 pounds 1 ounce. Cranford First Aid Squad personnel and an advanced life support unit from the Monmouth Ocean Hospital Service Corporation arrived with moments of the birth.

The family was transported to Saint Barnabas Medical Center (Livingston, NJ) by first aid personnel. According to Scott Kraft, both mother and child are doing well. The couple has since decided to recognize Hearn's efforts by giving Kace the middle name Nelson.

Officer Hearns was excited to assist with the birth and happy that Kace will share his name. "It's an honor and a blessing," he stated, "to be part of something special in their lives."

Cranford Police Chief James Wozniak had plenty of well wishes for the family and praise for his officer. "This is a great job all around, and I'm thrilled that the result is a

happy, healthy baby boy. This is the kind of thing my officers train for," he noted, "but it is still rewarding to see the actions of a Cranford police officer having a positive impact on someone's life. I'm incredibly proud of Officer Hearns and everyone else who was present."




Cranford and the September 11, 2013 robbery of Lusitania Savings Bank in Hillside NJ. The investigation culminated in the arrest of Andrew Thomas and Jennifer Pinto following the Hillside robbery.

At a ceremony held on February 12, 2014 at the Newark Field Office of the FBI, Special Agent in Charge Aaron Ford presented certificates of appreciation to members of the Cranford Police Department Investigative and Traffic Divisions. The United States Attorney for the District of New Jersey, Paul J. Fishman, was in attendance, as was Cranford Police Chief Eric G. Mason.

The following officers received certificates and letters of recognition from the FBI: D/Lt. Edward Davenport, D/Sgt. Gerard Quinn, D/Sgt. Christopher Polito, Det. John Swandrak, Det. Robert Montague, Det. Ryan Greco, Det. Russell Luedecker.

Current Cranford Chief of Police James Wozniak cited the interagency cooperation that led to the arrests. He stated, "Crime doesn't always recognize municipal and county borders. and to ensure our continued success we need to constantly develop and maintain working relationships with our neighboring agencies."

The Cranford Varsity Wrestling season started in late November and ran until early March, but in true championship fashion the season never ends. Throughout the offseason the wrestlers are training hard and the coaches, parents and alumni are hard at work organizing fundraisers, attending camps, and driving their children around the tri-state area seeking out the best competition for the boys. All of this hard work both on and off the mat paid off with great accomplishments this year for the entire team as well as individually.

In only his third year as Head Coach, Pat Gorman and Assistant Justin Bonitatis had a lot to look forward to. Coach Gorman had mentioned earlier in the year that his goals were to win a team District 11 title, advance 10 wrestlers to the Region 3 tournament, and to place a wrestler on the state podium in Atlantic City in March. To prepare his team for this he beefed up their schedule adding in top 20 teams and traveling to new tournaments with tougher competition. In the end all of these goals were met and some exceeded. Along the way the coaches would achieve a milestone of their own, capturing their 50th win together, but before this was a reality there were weeks of grueling work coupled with long hours of sweat to put in.

In continuing with a new tradition the Cougars took to the road early in the season on a long bus trip this year, the destination was Raleigh, North Carolina. This trip was made possible by the endless efforts of fundraising through the Parents Club and the Annual Cougar Golf Outing held each summer. In North

Carolina a 43-team tournament awaited the Cappello 160lbs were all returning starters with Cougars, this was a tournament made of up teams from 5 different states all of which were represented by state placers and champions. Cranford made immediate impact there and finished as the tournament runner up, having three champions and four other placers. This successful tournament would set the bar for the season ahead.

The Varsity lineup at a glance was extremely young, four freshman, 4 sophomores, 2 juniors and only 3 seniors. In all there were seven new comers to the Varsity level. In addition to a young lineup the Cougars were forced to forfeit the 195lb weight class all season long, but even with the young lineup and only 13 of 14 weights filled, the team stayed focused on their goals. Having such a young lineup does not equate to an inexperienced one. The four freshmen (Anthony Capece 106lbs, Tom DiGiovanni 113lbs, Chris Scorese 120lbs, and Brian McGovern 132lbs), adequately nicknamed the Four Horseman, had been wrestling together in the PAL ranks for years and had amounted masses of matches between them. With all of that experience it was an easy transition as they exploded onto the High School scene with winning attitudes and a hunger to learn. Together these four accounted for over 110 varsity victories in their first year of high school competition!


In addition to these four, were those that had already been around and had Varsity experience under their belt. Sophomores Dave Busch 126lbs, Andrew Tompkins 145lbs, and Niko

a full Varsity season under their belt. Niko, a returning Dsitrict Champion, had also accomplished All Amercian status as a freshman. Junior Captain Gavin Murray 138lbs, also a returning District Champion, not only had two Varsity seasons to build on, but had advanced to the state tournament last season and earned a victory there as well. Senior Corey Birch 152lbs, was the only 4th-year varsity wrestler in the lineup, and Senior Captain Jon El-Khoury HWT was a returning starter. New to the Varsity lineup were Senior Paul Castillo, an alternate at 145lbs, Sophomore Chirs Kiamie 170lbs, and Junior Nick Ballas at 182lbs.

The Cranford wrestling team used this lineup to earn a 16-5 record, finish top 4 at the Neptune Classic, finish as runner up at the 43rd Annual WRAL tournament, finish as runner up in the Union County Tournament, advanced to the State Section Semifinals, win a District 11 title, and finish as top 6 in the Region. Along the way the Cougars recorded over 100 team pins, advanced 11 wrestlers to the regions, and advanced three of those wrestlers to the state tournament in Atlantic City.

At the county level freshman Tom DiGiovanni was crowned champion as was junior Gavin Murray who was also awarded the Outstanding Wrestler award. Finishing in second place were freshman Anthony Capece, sophomore Dave Busch, and sophomore Niko Cappello. Freshman Brian McGovern finished with a third place.

At the district level freshman Tom the 138lb bracket. None of that phased Gavin as Digiovanni, freshman Chris Scorese, freshman Brian McGovern, junior Gavin Murray and sophomore Niko Cappello were all crowned Champions with Chris Scorese winning the Outstanding Wrestling award. Freshman Anthony Capece took a second, and sophomore Andrew Tompkins, junior Nick Ballas, and seniors Corey Birch, Mike Pastor, and Jon El-Khoury all placed third. In addition to the accolades that the wrestlers earned Assistant Coach Justin Bonitatis was awarded the District 11 Assistant Coach of the Year honors.

At the region level junior Gavin Murray earned his 100th career victory on his way to being crowned Region 3 Champion. Freshman Tom DiGiovanni and sophomore Niko Cappello both finished in third place earning all three the prestigious honor of advancing to the state level at Atlantic City. At Boardwalk Hall all three wrestlers won their first bout advancing them to the next round, where only Gavin was fortunate enough to continue on. Section 212 was packed with family, friends, and alumni all decked out in their Cranford gold shirts showing unconditional support for their wrestlers. An unseeded Gavin put together a string of victories which included pinning the number 2 seed in the quarter finals and beating the number 3 seed in the semi finals. In exciting fashion Gavin wrestled his way to the state finals where only 7 other Cranford wrestlers have graced the circle.

An undefeated Gavin was pitted against the heavy favorite from Paulsboro, the nationally ranked wrestler who was the number one seed in

He pushed the pace of the match from start to finish, a pace that his opponent had trouble keeping. After the final whistle Gavin fell short of the victory by one point, but earned the respect of all in attendance with his style of relentless wrestling. State runner up as a junior is an excellent achievement for Gavin, his family, and the entire Cranford wrestling program. In addition to these great achievements, Gavin Murray was recently named the Union County Wrestler of the Year 2014!

"I am so proud of the way Gavin wrestled this tournament, I am proud of all three of the boys

that represented Cranford down here. All year we have been preaching that hard work pays off and to never give up, each match is a six-minute fight, and that's what we saw here this weekend, the will to win!" Said Coach Gorman.

The season came to an end at Boardwalk Hall in Atlantic City with much of the state talking about Cranford wrestling as an up and coming program. It is no secret that the Cranford PAL program has been growing and having great success for years. They are producing well balanced wrestlers who will continue to feed the high school wrestling room for years. AMBER BROWN AUTHOR INSPIRES STUDENTS

Elizabeth Levy shares insights and stories at Orange Avenue School

"Do your teachers talk to you about adding details to your writing?" children's author Elizabeth Levy asked the group of fifth-grade students.

A resounding, "Yes!" went up from the audience. "Well, welcome to the world of writing!" Levy responded enthusiastically. "Authors work very hard to include the right details in their stories. They want the details that make the characters and the places they live come to life. Always remember, if the detail is interesting to you, it will be interesting to your reader."

And Ms. Levy should know a thing or two about what interests young readers. She is the author of more than 100 children's books including some for the acclaimed Amber Brown series. Ms. Levy began writing for the children's book series after her dear friend and originator Paula Danziger died in 2004.

"Paula was always my first reader," Ms. Levy explained. "She would tell me to put a red line though the funny lines. A blue line through the sad lines. And when I looked at the page, what would I see? Purple! The funny and the sad together, just like real life."

Levy shared lots of writing advice with the students and encouraged them to write from the heart. "You have to get to the deepest parts of you to make your writing come alive. Don't be afraid of the way you feel."

She also told them not to be discouraged by the editing process.

"Do you think your teachers give you too many comments on your work?" she asked. Another resounding, "Yes!" from the crowd. "Well, take a look at this."

Levy shared her writing drafts, pages full of arrows, red lines, scribbled comments in the margins, and even long letters from editors about character motivation and development.

"See what goes into it? Don't be scared or annoyed by rewrites and revisions. It is part of the process. It is part of what makes your writing


and your stories better."
